# IMPORTANT INFORMATION REGARDING YOUR MANDATORY REQUIREMENTS

Prior to commencing clinical placement, there are many mandatory requirements set by UniSC, Queensland Health, and other facilities.

It is important you understand what is required and that you complete all requirements according to the Workplace Integrated Learning (Placement) Procedures.

Please log in and review each individual link to ensure you complete the correct requirements and that you understand your obligation as a UniSC student.

## Important Mandatory Requirements Information and Timelines

- The Fit For Placement Office will send out communications to groups *6-8 weeks prior to their course start date*.
- *First-year students* will receive communication *approximately 7 months before the placement block starts*.
- Students will receive a *Reminder email* from the Fit For Placement Office *approximately 2 weeks before the due date for mandatory requirements*.
- *Failure to submit your mandatories by the due date* will prompt an email indicating your *placement is at risk*.

## Site Specific Pre-Placement Requirements:

- In addition, Some placement host organisations may require students to complete site-specific requirements and training modules, which can be accessed through the Placements tab on Sonia Online.
- Approximately 3 weeks before students start their placement, those allocated to a **Queensland Health & Hospital Site (HHS)** will receive further communication from Fit For Placement Office regarding their Student Orientation Checklist, Deed Poll and iLearn modules along with step-by-step instructions.
- Students allocated to **Queensland Health** sites will receive additional communication from Fit for Placement Office about completing their pre-placement site-specific requirements.
- Please note that some placement host organisations **may still require COVID-19 vaccinations**. If you are not fully vaccinated, it is important to know that placement opportunities in this program may be limited. We do encourage you to upload your COVID-19 vaccination evidence as soon as possible, to support the allocation process.

By following these steps, you will ensure that you stay informed and fulfill all mandatory requirements for your placement, including any specific requirements for Private facility placements.
